# CALL TO REVERSE DECISION TO DROP SERIOUS ROAD INJURY TARGET IN EU

More than 40 experts and representatives of road safety organisations and victims groups from across Europe together with 11 members of the European Parliament have written to



President Jean-Claude Juncker urging him to reverse a decision to drop the announcement of a new EU target to cut serious road injuries. PRI also supported the call.

Recently it was apparent that the announcement of the target has been dropped and no new date has been set for its publication. According to ETSC analysis at least 200,000 people suffered lifechanging consequences resulting from traffic collisions last year alone, an increase of 3% from the previous year. Furthermore, over recent years, declines in serious road injuries have not matched the reductions in road deaths.

# DUTCH INVESTMENTS IN CYCLING - BENEFITS FOR HEALTH AND ECONOMY

The study clearly shows that

Dutch investments in bicycle-promoting policies, such as improved bicycle infrastructure and facilities, are likely to yield

a high cost-benefit ratio in the long term. Health benefits translate into economic benefits of over 5% of Dutch GDP. With a Dutch VSL of  $\in$  2.8 million per prevented death, investment in cycling is an extremely wise economic investment. The  $\in$ 0.5 billion per year spent by the Dutch government on road and parking infrastructure for cycling is estimated to yield total economic health benefits of  $\in$  31 billion per year!

# EUROPE MUST BOOST SAFETY FOR CYCLISTS AND WALKERS

7,600 people died in road traffic while cycling or walking in the EU in 2013 according to new research: the equivalent of a commercial airliner full of passengers being lost every week.



The European Transport Safety Council (ETSC), authors of the new report, say unprotected road users need special attention because the numbers being killed are falling more slowly than those for vehicle occupants. In the last ten years, deaths among pedestrians and cyclists fell by 41% and 37% respectively, while vehicle occupant deaths fell by 53%.

Since 2010 the reduction in the number of pedestrian and cyclist deaths has slowed down markedly with numbers falling by only about 10% and 3% respectively between 2010 and 2013.

The risk of being killed in traffic as a pedestrian differs greatly among European countries. It is lowest in The Netherlands and Scandinavia, but about 6 times greater in Latvia, Lithuania, Poland and Romania. Latvia and Lithuania are responding to this challenge by achieving two of the fastest reductions in risk. (Source ETSC)

Stop the Crash will be launched in Brasilia on the occasion of the 2nd Global High Level Conference on Road Safety in November. The meeting will carry out a mid-term review of the UN Decade and highlight priorities for action to 2020 and beyond. The launch will also coincide with the 2015 Annual Meeting of Global NCAP which will bring together all of the active vehicle safety consumer testing programmes worldwide. (Source: Global NCAP)

### **GREEN LIGHT FOR SAFE SCHOOLS SOUTH AFRICA**

The installation of a <u>signalised pedestrian crossing</u> means that for the first time, the 1,150 school children of Sivile are now able to reach their classes safely.

Speaking at the opening of the new crossing, <u>Zoleka Mandela said</u>: "Until the Safe Schools project began, there was little on the roads to offer protection. Now we have a safe crossing. It sounds a simple solution, but it is a life-saver."



iRAP assessments of the original site concluded that the main point at which hundreds of children crossed to school each day had a 'one star' safety rating. It was estimated that a signalised pedestrian crossing could reduce pedestrian risk by as much as 85%.

The first phase of the Safe Schools project will be finalised towards the end of 2015 when the City of Cape Town completes the installation of the new infrastructure at other pilot project schools. (Source: iRAP)

#### NEW E-BOOK HIGHLIGHTS AFRICA'S ROAD SAFETY **CHALLENGE**



The United **Nations Economic** Commission for Europe (UNECE), the United Nations Economic Commission for Africa (UNECA), and the International Alliance for Responsible Drinking (IARD) launched a publication today focused on improving road safety and reducing drink

driving in Africa.

Preventing Drink Driving in Africa is the outcome of the UN Road Safety Conventions and Approaches to Preventing Drink Driving workshop, organized by the three institutions and held in Addis Ababa, Ethiopia in November 2014. The e-book includes new survey results on road safety issues across the African continent, updates on the implementation of the African Road Safety Action Plan, and recommendations and international good practices to improve road safety. It also includes videos and presentations from the workshop.

These recommendations include providing African nations with more UN capacity-building support in implementing provisions of UN road safety conventions, and exploring increased engagement with the private sector in applying road safety laws and regulations, with a particular focus on the transportation of dangerous goods. # UN SG'S SPECIAL ENVOY FOR ROAD SAFETY

United Nations Secretary-General Ban Kimoon announced on 29 April 2015 the appointment of Jean Todt as his Special Envoy for Road Safety. Mr. Todt is the President of the Fédération Internationale de l'Automobile (FIA).



The Decade reaches its mid-term review this year (2015) with little observed change in the number of global annual road traffic deaths.

With motorization rates rising rapidly around the world corresponding to economic growth, especially in low- and middle-income countries, it is timely and imperative for all countries now to make tangible progress in improving the safety of their roads if they have not yet started to do so, and to further improve their road safety record. It is within this context that the United Nations Secretary-General has appointed Mr. Todt as his Special Envoy for Road Safety. UNECE will act as the secretariat for the Special Envoy for Road Safety.
